### Why Worldview and Politics Are Related:

*“There just aren’t enough people in office, or out of office, who are willing admit the problems we have and take actions necessary to address them.”*

(Montana Congressman Matthew Rosendale, personal TEXT, 9/5/2024)

- **Note to those outside of Montana:** The section 1-3 of this guide is very relevant to you.

**This voter’s guide is written for the engaged voter**, if you’re looking for sound-bit thinking, this may not be for you. However, there is a table of contents so you can choose what you read. **It is a combination of voters’ guide, hopefully fileted through the lens of Christian Worldview thinking, to address the current situation in Montana and America.**

Some have suggested that politics and worldview issues are in different purviews. Many Christian leaders have adopted this thinking arguing that **politics** - or **cultural issues** if you will - are not in their purview. This has been the posture of too many churches.

As the church has declined to teach about cultural issues such as abortion, same-sex marriage, transgenderism, religious liberty etc., these **issues have moved into the political arena**. There is an old Axiom that states that ***Policy Promotes Practice***. Translated that means once the public sees a policy being adopted politically, they tend to adopt that thinking. Prime Example, same-sex marriage was much less popular before the Supreme Court said it was the law. Before that, same-sex marriage was not nearly as popular and was not legal in many states. Now, even 69% of Catholics have adopted this unbiblical thinking and the Evangelicals are just as bad.

If you think these moral-ethical issues are not on the ballot, you are not paying attention

What is [The Spiral of Silence](#) and what is its effect? (See explanation in End Notes) A [three minute YouTube](#) explains it. It is the reality that people, leaders in particular, are **sensitive to whether their opinion is generally compatible** with

public opinion or influencers. In simplistic terms, the more one realizes that they are out-of-step with public opinion, **particularly about moral- ethical issues**, the more inclined they are to **increasingly spiral more silent** about those issues as culture spirals down. In no issue has this been more evident than in the issues of same-sex marriage. The more the public accepted it, the more silent Christian leadership became on it. an

**This voter's guide is NOT just aimed at Christian.** I do believe that most conservative voters will appreciate my stand on social issues.

I always strive to message through the lens of a Christian worldview, keeping in mind what Jesus said about Truth and not wanting to shrink back. I will address issues in this voter's guide that relate from abortion to Marxism, embracing Truth as Jesus would when He said ***"For this reason I was born, and for this reason I came into the world- to testify to the Truth"*** (John18:37)

Rightly did the respected Dutch theologian Abraham Kuper (1837 to 1920) prophesy when he said:

***"There is not one square inch in the whole domain of our human existence over which Christ, who is Sovereign over all, does not cry, Mine!"***

#### **Focus in this General Election:**

A word of concerning the recent Primaries. As I looked at the Primary numbers across races in Montana – **the numbers told a resounding, disappointing story. Uninformed voters who voted for incumbents, big names, without due diligence.** The imbalance in the numbers simply did not reflect the reality of the differences between the two candidates – in race after race. It was not about who won or lost, it was about the lopsided numbers in so many races.

**This focus will be on the Montana Supreme Court, the Presidency, and ballot initiatives.** This edition of the Voter's Guide relates to the November General election. I will not reference races of Republicans vs. Democrats – or Libertarians or Green Party. If you wish to look back at my Voters Guide for the Primary you can find it [Here](#).

I will only support Republicans so I am assuming you will have clear choices on your ballots. The [Democratic party has become radicalized, anti-American, pro-](#)

[Marxist](#) and anti-Christian. Their candidates are either complicit or so naive that they should not be supported. I am not shy to say that **Kamala Harris is an enemy of America and Christianity**. She has thumbed her nose at God.

**I do not assume** you must vote for all Republicans. You may choose to leave some of the boxes blank and not vote for certain candidates based on your own principles. The older I get – and the more I observe of government – the less I subscribe to the guilt-mantra “*hold your nose and vote for the candidate you hate the least.*” **In some of the races, this has become out-right bullying, shaming of people who won’t comply with the establishment.** Much of the time, this has been orchestrated by elements of the [Establishment or Uni-Party](#).

### **Feminism – the *Stealth-Trojan-Horse*:**

#### **Why It Matters – In Montana and America.**

**First, I will address the Feminization of our culture because it is a critical issue in this election.** From a worldview perspective, I believe it is the most important issue of *our times*. However, I believe the data and the polls reinforce my argument.

**Knowing what we should do:** I Chronicles 12:32 is a challenge for us, just as it was for the men of Issachar in their day, to ***understand our times and know what to***

**do.** With that in mind, I will take a moment to address what I believe is a ***defining issue in our times.***

Addressing the outcomes of Radical Feminism is difficult because the public is so unaware of its history and influences. As you research the subject, you soon realize that the Feminist movement was a **primary tool of the Marxists** to change America!

**I will also outline why I am persuaded that this issue could deliver the Presidency to a Radicalized, Feminist.** Have you been following the polls that indicate that women – especially young women - [are breaking for Kamala](#)? Follow me for a few minutes.

I had a conservative get upset with me for talking about feminism. This person obviously knew little of the history and influence of 2<sup>nd</sup> and 3<sup>rd</sup>, wave feminism – and - its current impact. They thought I was just attacking women; the truth is, it has had just as much effect on men – arguably, more.

The movement's roots are **deeply embedded in Cultural Marxism.** In fact, the Marxists have used this movement for a century – much the same as they are now using *Critical Race Theory* and *Diversity, Equity, and Inclusion* today. You can see some of the studies I have made in **six books in the End Notes below.** You will see that I have filtered through about 2,000 pages by some excellent authors, not to mention dozens of articles.

Every one of the leaders of this movement have been broken people- mostly women - who were intensely committed to Marxism. **One of their main themes has been selling the Marxist theme of “the oppressed and the oppressors?”** By the 60's they had progressed to the point where they could **sell this to American housewives** – promoting the idea that you were “just a housewife” and **not a career woman**, you had been deprived of your rights. And it sold like hot cakes on a frosty morning.

**Marxists worked**, starting a century ago, with key influencers to give us the Feminist movement and abortion, the sexual revolution, the Trans movement, and same-sex marriage etc. all followed.

This ideology is not well recognized – much less – understood. Being free from its influence – in America – is like trying to swim in a pool without getting wet. In her

excellent book [\*The End of Woman: How Smashing the Patriarchy Has Destroy Us\*](#), Carrie Gress outlines - just the history - not the philosophies of this movement **in the last 100 years**. Just three articles for your consideration that may help you understand why I risk talking about this volatile subject.

If you think conservative women **won’t vote for a woman just because she is a woman**, take a look at Montana! [I have made the case](#) in some detail (p.3) that **Republican woman** in the Western Montana Congressional race in 2022 cast thousands of votes for a candidate **only because she was a woman. Don’t believe me?** Follow the LINK and draw your own conclusions.

**What about America?** This [above mentioned article](#), (how women are breaking for Kamala) **is complex** but this part is of what it points to:

*...Across the six states identified above, though, there was a **10-point shift in the margin to Harris’ benefit among women** — almost twice as large in the Sun Belt states (Arizona, Georgia and Nevada) than in the “blue wall” states (Michigan, Pennsylvania and Wisconsin) ...*

There is lots to consider, the article [\*Kamala Harris’ Chances in November Could Hinge on Women’s voting Surge\*](#) is even more troubling.

**Abortion** is on the ballot, just as it is in Montana, and you’re dreaming if you think large numbers of Republican women won’t support it. **Why?** Partly because they have **never heard a good case made against abortion** in their churches. This is a

key reason why we need to pray for CI-128 to be defeated – abortion is popular in Montana 😞.

But the march goes on as shown by this article [The Gender Gap Widens in the Harris Trump Contest.](#)

*Take the recent New Your Times/Sierna College poll Harris **holds a 14-point lead over Trump among likely female voters (55% to 41%),** while Trump holds a 17-point lead among men (56% to 39%). That’s a net 31-point gender gap.*

**OR**

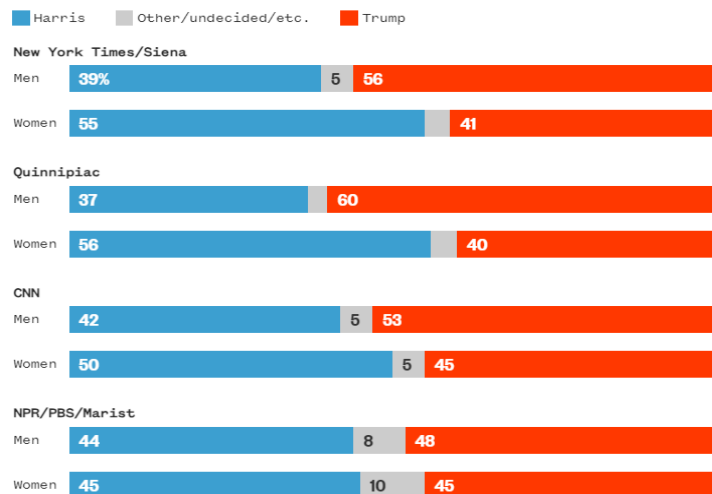
*It’s even bigger in the latest Quinnipiac University poll, **where women are breaking for Harris by 16 points (56% to 40%)** and men are siding with Trump by 23 points (60% to 37%). (Note: The Quinnipiac poll was conducted before and after Biden exited the 2024 race.) That’s a whopping 39-point gender gap.*

It is critical that people understand who Kamala Harris is, she perfectly fits the mold you will see below. In the Federalist article (08/07/24) [Hating Men is Now the Democratic Campaign Strategy](#), we see that **Harris knows who her voting base is and it is women of all stripes**, particularly single women. Just a couple of relevant quotes:

- *“Simply stated, it’s a fully intentional effort by the Harris campaign to make the 2024 electorate **split about sex, not policy...**”*
- [For starters, a February 2024 Pew Research Center study shows men are now more interested than women in starting families by a margin of 57 to 45 percent.](#)

The last part makes it crystal clear that a **huge percentage of America’s women have been evangelized by Radical Feminism** – most are not even aware of it. Cory joined the Montana National Guard in 1997 and was commissioned as a 2nd Lieutenant in 1998. He was deployed to the Middle East three times and currently holds the rank of Colonel. He got his law degree at the University of Montana. In January 2013, Swanson was hired as a Deputy Attorney General in the Montana Department of Justice. Cory's challenger is...

**Jeremiah (Jerry) Lynch**, for Chief Justice. Lives in Missoula, Butte native. [lynchformontana.com](http://lynchformontana.com) Jeremiah (Jerry) Jerry served 13 years as a Federal Magistrate – **he has never been elected to a bench position.** At age 71 he is coming out of retirement (2019) to run. The question is **why?**

Progressives can be very crafty at disguising motives, especially in the judiciary. **The ACLU (a Marxist organization) is financing TV ads boldly promoting that he will fight to protect abortion from the bench even as our current Supreme Court has with CI-!28.**

You often have to **pick up bits and pieces** from different articles. One of the things, you begin to sense with this individual is **a motive of activism on issues.** As you are vetting candidates, look for **buzz words or phrases**, so let's look at a couple here:

- **He is very Pro-Abortion:** In the one-minute video on his webpage you hear. *He is a **Staunch advocate** of the Montana Constitution with its “**protection for the right to privacy**”* – this phrase has been used by our Supreme Court to support the right to abortion. (See [Armstrong v. State](#) issue discussion).
- **He is a Climate Change Activist:** The Montana Constitution guarantee of “**a clean and healthful environment**” – this phrase is currently being used by a group of kids from Missoula to sue the state for environmental pollutions and our Supreme Court has taken their side.
- **More Environmentalism:** *Embraces a **sustainable** future for the Big Sky State* – the word sustainable is almost always a **signal of environmentalism** and if you read his experience, you find this in his background.

- He speaks of the “*brilliant career in public service of Chief Justice McGrath.*” Actually, McGrath has the distinction of **presiding for 16 years over the most liberal state supreme court in America.**

**Judge Dan Wilson - for Associate Supreme Court Judge**, from Kalispell. Find him at [wilsonforjustice.com](http://wilsonforjustice.com) **Dan is the clear choice for Associate Justice.** In a meeting with Judge Wilson, you encounter a measured, man who is committed to the rule of law. He does not cave to special interests. This is the kind of man we want on our highest court. **He, alone, took on Governor Bullocks Covid mandates and destroyed them in Western Montana.**

**In case you're wondering why Dan did not get the vote count in the Primary** election that his opponent did, the explanation is this. There were three candidates for this office, two considered conservative. Jerry O'Neil was the other conservative-libertarian candidate who took about 20K votes. Reality is that, while Jerry appears to be a good man, he was not qualified to run for this office and never should have been on the ballot. You have to be recognized to be a lawyer by the State Supreme Court and have to have practiced for five years. O'Neil had done neither. The Republican Party failed to challenge this and so did the Commissioner of Political Practices – both should have. Little wonder why the Democrats didn't challenge this – it had potential to work in their favor. Jerry had worked on the Reservations, but not as a member of the Bar. You can argue that lawyers should not have to complete law school and could just take the Bar. Fine but change the law, don't just complain. **Judge Katherine Bidegaray for Associate Court Judge. How do you spell LEFTIST?**

**More Buzz words** - she has also said she is *a visionary, an innovator*... poised not merely to follow, but **to lead**. This is activist language. We don't want this activist judge anywhere near the Montana Supreme Court.

**It is absolutely essential – above all else – that we get Cory Swanson and Judge Dan Wilson elected**. **spiral of silence**, in the study of [human communication](#) and [public opinion](#), the theory that people’s willingness to express their opinions on controversial public issues is affected by their largely unconscious perception of those opinions as being either popular or unpopular. Specifically, the perception that one’s opinion is unpopular tends to [inhibit](#) or discourage one’s expression of it, while the perception that it is popular tends to have the opposite effect. Developed by German survey and communication researcher Elisabeth Noelle-Neumann in the 1960s and ’70s, the [spiral](#) of silence theory more broadly attempts to describe [collective](#) opinion formation and societal [decision making](#) regarding issues that are controversial or morally loaded.

In the [context](#) of the theory, the term *public opinion* refers to opinions or behaviors that can be displayed or expressed in public without running the risk of social isolation or, in some cases, that even must be displayed to avoid the danger of isolation. Thus, *public* is not meant in a legal or political sense—as something that is freely accessible to all or that concerns the general population or society as a whole. Instead, the concept is interpreted from a social-psychological perspective as a state of [consciousness](#) in which individuals are aware that their actions are “seen by all” or “heard by all,” requiring that they constantly monitor

not only their own actions but also the reactions of others in their [environment](#). Accordingly, Noelle-Neumann viewed public opinion as a form of social control that ultimately applies to everyone, regardless of [social class](#), and that is apparent in many areas of life, ranging from controversial political issues to fashion, [morals](#), and values. Such an understanding of public opinion differs markedly from the traditional [conception](#), according to which most people's opinions on public issues are influenced by rational debate among educated elites.

### **Origins of the theory**

The theory of the spiral of silence arose from a surprising discovery in connection with [election](#) research conducted during the 1965 German federal election campaign. Months before election day in September 1965, Noelle-Neumann and her staff at the Allensbach Institute for Public Opinion Research launched a series of surveys designed to track the political opinions of the electorate throughout the campaign. From December 1964 to shortly before election day, survey findings on voters' intentions remained practically unchanged. Month after month, the two major parties, the governing [Christian Democratic Union](#)–Christian Social Union (CDU-CSU) and the opposing [Social Democratic Party of Germany](#) (SDP), were in a dead heat, with about 45 percent of the population intending to vote for each party. Under such circumstances, it seemed impossible to predict which party was most likely to win the election.

In the final few weeks of the campaign, however, the situation suddenly changed, with survey findings showing a last-minute swing in favor of the CDU-CSU. The percentage of respondents who said that they intended to vote for the CDU-CSU suddenly climbed to almost 50 percent, while the share that intended to vote for the SDP dropped to less than 40 percent. In the end, the result of the election confirmed those findings: the CDU-CSU won with 48 percent of the vote, as against 39 percent for the SDP.

Interestingly, while voters' intentions remained unchanged over the course of many months, their expectations regarding the outcome of the election shifted dramatically during the same period. In December 1964, the percentage of respondents who expected the SDP to win was about the same as the share who anticipated a CDU-CSU victory. But then the results began to change: the percentage of respondents who expected a CDU-CSU victory rose continuously,

while the SDP lost ground. By as early as July 1965, the CDU-CSU was clearly in the lead regarding voters' expectations, and by August, almost 50 percent expected that it would win. Late in the campaign the bandwagon effect came into play, as a sizeable number of former SDP supporters or undecided voters cast their ballots for the party, they expected to be victorious.

How could party strength have remained constant for so long while expectations as to who would win changed so dramatically? Noelle-Neumann suspected that a visit by Queen [Elizabeth II](#) to [Germany](#) in May 1965, during which she was often accompanied by the Christian Democratic German chancellor, [Ludwig Erhard](#), may have created an optimistic mood among supporters of the CDU, prompting them to publicly proclaim their political [convictions](#). As a result, supporters of the SDP may have (wrongly) concluded that their opponents' opinions were more popular than their own and that therefore the CDU would win. SDP supporters were accordingly discouraged from publicly [articulating](#) their own views, reinforcing the impression that the CDU was more popular and more likely to be victorious.

### **Key elements of the theory**

According to the spiral of silence theory, most people have a natural—and mostly unconscious—fear of social isolation that prompts them to constantly monitor the behaviors of others for signs of approval or disapproval. People also issue their own “threats” of isolation—mostly unconsciously—through behaviors such as criticizing someone, turning away from someone, scowling at someone, laughing at someone, and so on. To avoid isolation, people tend to refrain from publicly stating their views on controversial matters when they perceive that doing so would attract [criticism](#), scorn, laughter, or other signs of disapproval. Conversely, those who sense that their opinions will meet with approval tend to voice them fearlessly and at times vociferously. Indeed, speaking out in such a way tends to [enhance](#) the threat of isolation faced by supporters of the opposing position, reinforcing their sense of being alone. Thus, a spiraling process begins, the dominant camp becoming ever louder and more self-confident while the other camp becomes increasingly silent.

Importantly, the spiral of silence occurs only in connection with controversial issues that have a strong [moral](#) component. What triggers a person's fear of isolation is the belief that others will consider him or her not merely mistaken but

morally bad. Accordingly, issues that lack a moral component or on which there is general [consensus](#) leave no room for a spiral of silence.

As demonstrated by the 1965 German federal election and other examples, the actual popularity of an opinion does not necessarily determine whether it will eventually predominate over opposing views. An opinion can be dominant in public discourse even if a majority of the population actually disagrees with it, provided that most people (falsely) believe that the view is unpopular and refrain from expressing it for fear of being isolated.

Public opinion is limited by time and place. With few exceptions, a spiral of silence holds [sway](#) over only a single society (a nation or cultural group) and for only a limited period. When viewed in hindsight or from an outsider's perspective, it is sometimes hard to comprehend the agitation and emotional fervor that can accompany a spiral of silence.
